## **Membership Fees for the Bulgarian Green Building Council**

Each member appoints a contact person.

Umbrella organizations that consist of legally independent sub-organizations - such as corporate groups with independent companies - can apply for group membership. Independent sub-organizations are not automatically members themselves if the holding is a member.

Eligibility for group membership is possible if the umbrella organization is a member. The umbrella organization must be a parent organization, not merely a merger of individual organizations. The umbrella organization shall pay the membership fee for its category in full. The candidate for membership from a sub-organization can then become a member at a 50 percent reduction off the regular membership fee. Such sub-members enjoy all of the privileges of full membership except for voting rights, which only the umbrella organization has. Sub-organizations that wish to have voting rights must become full members on their own.

The Annual membership fee has to be paid within fourteen days of the application's registration.

For the first year of membership, the annual fee is equal to the part for the rest months of the calendar year. Membership fee payment must be made to the following account:
